

PLAYERS AFFILIATION AGREEMENT

THE RAINBOW YOUTH SOCCER LEAGUE OF NEVADA (RYSL)

In consideration of, and in return for, membership in the Rainbow Youth Soccer League of Nevada (RYSL), the registered player and his/her parents/legal guardians, hereby agree as follows [Person(s) refers to parent(s)/legal guardian(s)/registrant]:

- That the person(s) signing this form is/are also signing for the player, their spouse and/or significant other.**
- That the person(s) signing this form agree(s) to communicate the terms of this form to, and be responsible for the actions of themselves, their spouse and/or significant other, the registered player, family members, relatives and guests who attend any RYSL Events.**
- That we (registered player, his/her parents/legal guardians, family members, relatives and guests) will fully comply with the Clark County Ordinance 19.04.030; the NRS Chapter 651; 651.020; 651.050; 651.050(e) & 651.050(m), the RYSL Parent Code of Conduct, RYSL Player Registration Form (Front & Back), RYSL Team Sideline Policy, RYSL Disciplinary Policy, RYSL Summary of Rules, Constitutions, Bylaws, Policies & Procedures, Rules & Regulations of both the National Affiliate the RYSL is affiliated with and the RYSL and all decisions of the President & Board of Directors (BOD) of the RYSL. We also agree to inform all family members, relatives and guests we bring to the practices, matches and activities of the aforementioned Rules, Policies, Procedures, CC Ordinances and NRS Chapters and we agree to be responsible for their actions.**
- That it is understood and agreed (registered player, his/her parents/legal guardians, family members, relatives and guests) that our failure to read and/or comprehend any of the provisions of the aforesaid Constitutions, Bylaws, Policies & Procedures, Rules & Regulations, Registration Forms and Code of Conduct and decisions of the President & BOD of the RYSL shall not excuse noncompliance therewith and violators may expect appropriate action by the BOD of the RYSL.**
- That we (registered player, his/her parents/legal guardians, family members, relatives and guests) shall not invoke the aid of any outside of Youth Soccer agency or entity or Governmental agency or entity or the Courts of Nevada or of the United States, without first exhausting all available remedies, including Protest and Appeal through the RYSL, and any other regular channels of organized soccer. Regular channels of organized soccer shall include the National Affiliate that the RYSL is affiliated with and the United States Soccer Federation (USSF). In the event we, or any member of the team, their family members, relatives and guests, shall violate the terms of this paragraph, we agree to pay for any and all costs, expenses and attorneys' fees incurred by the RYSL in defending against any such premature action.**
- A youth player is defined as any player who can qualify to play U19 or younger, playing on any team within the jurisdiction of the RYSL.**
- Any player rostered with a team is bound to that team as outlined in the RYSL Policies & Procedures.**
- That we (registered player and his/her parents/legal guardians) fully understand that any misrepresentation or untruth relating to this registration will lead to immediate suspension from the RYSL for the current season and could jeopardize any future registrations.**
- That as used in this Agreement, and deemed appropriate by the RYSL, the singular shall include the plural and the plural shall include the singular.**
- That the person(s) signing this form is/are consenting and agreeing to the use of the registrants name and any photographic/digital images of the registrant, his/her parents, legal guardians, family members, relatives, and guests in marketing, advertising and/or promotion of Soccer by FIFA, USSF, the National Affiliate that the RYSL is affiliated with and the RYSL.**
